WWTP GRAVITY BELT THICKENER REPLACEMENT, CIPWW00028, CIPWW00005

Sealed bids for the **WWTP GRAVITY BELT THICKENER REPLACEMENT** will be received at the front desk in the main lobby of Gresham City Hall, 1333 N.W. Eastman Parkway, Gresham, Oregon 97030, addressed to **Rob Chapler**, until **Thursday, March 3 AT 2:00 PM** local time. Late bids will be retained unopened. The bids will be publicly opened immediately thereafter **in front of Gresham City Hall near the main entrance**. The Engineer's Estimate for this project is \$2,816,000.

The Work of this Contract under the Base Bid generally includes the following:

- Thickening Equipment Replacement – Replace 3 Gravity Belt Thickeners with Rotary Drum Thickeners. Coordination with Owner's system integrator to connect the new equipment with the plant SCADA system.
- Pump Replacement – Replace three existing Thickened Sludge Pumps and equipment pads. Coordination with Owner's system integrator to connect the new equipment with the plant SCADA system.
- Installation of flow measurement and solids analyzer instrumentation. Coordination with Owner's system integrator to connect the new equipment with the plant SCADA system.
- Installation of hot water system.
- Installation of ventilation monitoring and go/no-go lighting for NFPA compliance.

The apparent low bidder will be required to have the current edition of the City of Gresham Public Works Standards.

A **VOLUNTARY** Prebid conference will be held on **February 22, 2022**. A Microsoft Teams web-based meeting invite can be requested through the City Project Manager by email. Project site visits are encouraged and can be requested of the City Project Manager by email. Site visits will be scheduled individually with contractors following the City's then current operating contractor's COVID-19 distancing policy's, currently face coverings and 6-ft. separation.

This project is for public work and is subject to ORS 279C.800 to 279C.870, the Oregon Prevailing Wage Law.

All bids must be submitted on the forms furnished by the City of Gresham, mailed or delivered in a sealed envelope plainly marked "SEALED BID for WWTP GRAVITY BELT THICKENER REPLACEMENT" and bearing the name and address of the bidder. The bid

must be accompanied by a certified check, cashier's check or bid bond in an amount not less than ten percent (10%) of the total bid.
