Demolish Existing 2-Story Building and surface parking to redevelop the entire site to accommodate two projects in a partnership between Mercy Housing Northwest and Mary's Place. Mercy Housing Northwest is developing a new 4-story multi-family building (plus basement) containing 91 units. Tenant common areas and offices will be provided at Level 1.
